Reservations / Minimum buy-off / Consumption coupons

Please use our online reservation system.

The reservation is for each one table. There is space for 8 to 10 people per table.

A reservation is associated with a minimum purchase of 50 consumption vouchers per table.

The consumption vouchers have a value of €10 each and are offset against all food and drinks, that we offer on our food and drink menu. All reserved seats include service (no self-service).

The purchased coupons are only valid for the current season. Not used-up coupons can be used at other fairgrounds where Festhalle Bayernland is represented.

Further consumption can be payed cash or by card.

Misuse of coupons will be prosecuted.

Consumption of food and drinks you have brought with you is not permitted.

The invoice amount is due immediately (within 8 days). After receipt of full payment on our bank account, the reservation is binding.

Consumption coupons (pick-up or shipping)

The possibility of collection begins on Monday, April 17, 2023 up to and including Friday, April 21, 2023, from 9:00 a.m. to 12:00 p.m. and from 1:00 p.m. to 5:00 p.m.

From April 22, 2023, the usual opening hours must be observed. (11:00 a.m. to 10:30 p.m.)

The pick-up point is directly located at the Theresienwiese in the marquee-office of Festhalle Bayernland. Please bring your printed one Invoice and your identity card with you.

Reserved seats

When we receive a reservation request, we try hard to accomodate the placement requests of our clients but we cannot guarantee appointed marquee areas or tables.

We reserve the right of relocating seats. In this case you would be informed.

Are there less than 8 – 10 people at the table the service staff is entitled to top up the table with other guests. There is no legal right for reserved seats.

Handing over a reservation to third parties is prohibited. We reserve the right of cancellation, if this rule is violated. In this case, there is no option of exchanging the coupons.

Claim to the reserved seats only starts at the confirmed time. Please take your seats in time and complete.

Reserved seats will be kept clear for maximum 15 minutes after the confirmed reservation time. In case of delay the claim to the seat is invalid.

With a binding table reservation you approve that the desired reservation name will be readable given to your seat ticket.

Cancellation / Disclaimer of liability

In case of reduction or complete cancellation of the reservation up to 14 days in advance of the festival there will be kept 15 % of the amount as an administration fee. For cancellations within the 14 days before the festival, 50% of the amount will be charged withheld.

Cancellations from the start of the festival are fully 100% of the amount will be charged withheld. Generally, reservations are only possible in writing.

Should force majeure occur **during the event** (terror, storm, epidemics, e.g. currently Corona Sars-Covid-19, etc.) there will be no refund.

In this case, further claims against H. u. P. Schöniger GmbH are excluded.

Payment / Billing

Please always check your table bill when making your payment. With your payment you confirm the correctness.
Later complaints are not possible and therefore excluded.
A processing fee of EUR 5 will be charged for your reservation.



SAFETY RULES

Please DON'T bring any backpacks or large pieces of luggage into the marquee. If necessary you won't be allowed to enter the marquee!

Please observe the separate reservation entry at the front of the marquee on Fridays and Saturdays or ask the security staff.

Fasten your admission ribbon to your wrist according to the regulations that the security staff can see that you have reserved.

Dancing on the beer tables is strictly forbidden.

Staying in the corridors **with** or **without** beer mugs **in** and **in front of** the reserved areas is prohibited due to fire prevention, escape and rescue routes are to be kept clear.

Drinking down a beer mug all at once is not allowed. In case of non-compliance the guest will be banished from the marquee.

Obviously drunk people can be denied entry – despite valid reservation.

Disguises / costumes in the marquee are unwelcome – admission is reserved

We don't take liability for accidents due to one's own fault

In case of non-observance of legal regulations the guest will be banished from the marquee.

It is prohibited to take or to publish photo or sound recordings of guests secretly or without their permission in and in front of the marquee. The H. u. P. Schöniger GmbH / Festhalle Bayernland doesn't take liability for this and can't be prosecuted for violations by third parties.

Our advertising photographer is allowed to take photo and video recordings in the marquee and to publish them only for advertising purposes of Festhalle Bayernland. If you stay in the marquee you agree to this.

It is prohibited to bring drinks, glass objects, weapons, drugs within the meaning of the law governing the use and traffic of drugs or other dangerous objects to the marquee. With our authority as a householder we are allowed to control carried objects (bags, backpacks, etc).

Please also note the following important information / regulations:

We point out the current pandemic regulations for SARS-Covid-19 and its mutant variations as well as new pandemics or epidemics must be complied with. Among other things, the current and specified infection protection measures (according to applicable law).

If you become infected with SARS-Covid-19 or other infectious diseases while in the marquee, H. u. P. Schöniger GmbH assumes no liability for this.

Disclaimer

If the event or single days can't be carried out due to official orders, safety considerations, force majeure, terror or other important reasons, purchased drink and food signs will be refunded.
