Reservations / minimum purchase / stamps

Please use our online reservation system.

The reservation is for one table at a time. There is space for 8 to 10 people per table.
A reservation requires a minimum purchase of 50 stamps of 12.00 euros per table.

The tokens have a value of €12 each and will be offset against all food and drinks. Which we offer on our food and drink menu. All reserved places include service (no self service).

The reservation fee is 1.50 euros per person and 15.00 euros per table.

The flat rate shipping fee within Germany is 10.00 euros. Shipping costs to other European countries are 20.00 euros. Shipping is via UPS, as vouchers are not sent by post for insurance reasons can be.
The dispatch of vouchers, reservation bands and the tent plan with marked
Reservations will be received from the end of January 2024.

The tokens taken are only valid for the current season. Unused tokens can be redeemed at other fairgrounds where the Festhalle Bayernland is represented (see www.festhalle-bayernland.de) (not at the Munich Oktoberfest) - no money will be returned.

Any consumption beyond this must be paid for in cash or with an EC card.
Any misuse of the stamps will be prosecuted.

The consumption of food and drinks brought with you is not permitted.

The invoice amount is due immediately (within 3 working days). The reservation is binding once payment has been received in full on our bank account.

Stamps (Collections)

The possibility of collection begins on Mon. April 15, 2024 until Friday, April 19, 2024, from 9:00 a.m. to 12:00 p.m. and from 1:00 p.m. to 5:00 p.m. From Saturday April 20, 2024, the usual opening hours must be observed. (11:00 a.m. to 10:30 p.m.) The pick-up location is directly on Theresienwiese in the Bayernland marquee in the marquee office. Please bring your printed invoice and your ID card with you.

If you pick up on the day of your reservation, you must have picked up your vouchers and admission wristbands at the festival office 1 hour before the start of the reservation. This allows you to make your reservation on time and keep main entrances as well as rescue and escape routes free.

Reserved Seats

We also reserve the right to postpone the location, in which case you will be notified by us.
If the table is not occupied by 8 - 10 people, the service staff is entitled to fill the table with additional people. There is no legal right to reserved places.

A reservation may not be passed on to third parties. In the event of a violation, we reserve the right cancellation of the reservation. In this case it is not possible to exchange the stamps.

Entitlement to the reserved places only begins at the confirmed time.

Please take your seats on time and in full.

**Reserved seats will be held for a maximum of 15 minutes after the confirmed reservation time.
If you are late, you will no longer be entitled to a seat despite having purchased a stamp.**

When you make a binding table reservation, you agree that the desired table will be reserved
Reservation name is legibly stated on the place card.

Cancellation / Disclaimer

If the reservation is reduced or completely cancelled, 15% of the amount will be charged retained as a processing fee. For cancellations within 14 days before the festival, 50% of the amount will be retained. Cancellations after the start of the festival are subject to a full fee.

Cancellations are generally only possible in writing.

If force majeure occurs **during the event** (terror, war or war-like conditions, storm, epidemics, e.g. Corona) there will be no refund.

In the event of a complete cancellation of the Spring Festival 2024, you will receive the fee you have already paid for Stamps back. Reservation fee and shipping fee will be retained for processing reasons.

In this case, further claims against H. u. P. Schöniger GmbH are excluded.

Payment / billing on the day of reservation (table invoice)

Please always check your table bill directly when making your payment. By paying you confirm the accuracy. Later complaints are not possible and are therefore excluded.

SAFETY INSTRUCTIONS



Bringing backpacks and large pieces of luggage into the festival tent is prohibited. If necessary, you will be denied access to the festival tent!

- On Fridays and Saturdays, please note the separate reservation entrance at the front of the tent or ask security staff.
- Properly fasten your wristband to your wrist so that security personnel can see that you have made a reservation.
- The security personnel must be obeyed.
- For fire safety reasons, it is not permitted to linger in the corridors with or without beer mugs in and in front of the reserved areas; escape and rescue routes must be kept clear.
- Smoking is prohibited throughout the entire marquee (including e-cigarettes)!
- The extinguishing of beer mugs is not permitted; failure to comply will result in expulsion from the tent.
- Dancing on the beer tables is strictly prohibited.
- People who are obviously intoxicated may be refused entry, despite having a valid reservation.
- Disguises / costumes in the tent are not permitted - entry remains reserved.
- Drinks and food brought along are not allowed to be sold at bachelor parties due to child protection and food law. In case of non-compliance, the security service can issue a ban from the house. Bachelor parties must be registered.
- We assume no liability for self-inflicted accidents.
- If legal regulations are not observed, the guest will be expelled from the tent.
- It is forbidden to make and publish images or sound recordings of guests in and around the tent secretly or without their consent. H. u. P. Schöniger GmbH / Festhalle Bayernland assumes no liability for this and cannot be prosecuted in the event of third-party violations.
- The advertising photographer we use is authorized to take photos and videos in the festival tent and to use them exclusively for advertising purposes of the company H. u. P. Schöniger GmbH (Festhalle Bayernland). When you stay in our marquee, you declare your consent to this.
- It is forbidden to bring drinks, glass objects, weapons, drugs within the meaning of the Narcotics Act or other dangerous objects into the festival tent. We are entitled to check items brought along (bags, backpacks, etc.) in the exercise of our property rights.
- Intentional damage to the facility, such as benches, tables, etc., is due immediately and must be paid on site. Otherwise, criminal charges will be filed for damage to property.
- Please also note the following important information / regulations:
We would like to point out that current pandemic regulations regarding SARS-Covid-19 and its mutants and variations as well as new pandemics or epidemics must be adhered to. Among other things, the current and specified infection protection measures (according to applicable law) always apply.
