General reservation and business conditions of the Festhalle Bayernland® for the Munich Spring Festival 2025

Opening and serving hours

The Munich Spring Festival will take place this year from 04/24/25 (April) to 05/11/2025 (May).
Our opening hours are Saturdays / Sundays and public holidays from 10:00 a.m. to 11:00 p.m. and weekdays from 11:00 a.m. to 11:00 p.m. (except on the opening day, 25/04/25 from 16:00 to 23:00)
The bar is served daily until 10:30 p.m.

Reservations / minimum purchase / stamps

Reservations can only be processed through our online reservation system, and will be shipped exclusively. Pick-up is not possible. All correspondence must be made via the reservation portal in accordance with your reservation. From **04/21/2025**, free seats can only be reserved **on site** in the Festhalle Bayernland directly in the marquee on the Theresienwiese, with immediate payment in cash or EC card.

Reservations can be made at the following times:

Friday 25.04.25 from 4:00 p.m. to 10:30 p.m. boxes and central ship seats

Friday 25.04.25 from 6:30 p.m. to 10:30 p.m. (rows 1 to 3 in front of the stage) due to the tapping these seats are blocked from 4:00 p.m. to 6:00 p.m.

from 04/26/2025:

Tables in the central nave from 11:00 a.m. to 4:00 p.m. and 5:00 p.m. to 10:30 p.m.

Tables in the boxes: from 11:00 a.m. to 5:00 p.m. and 6:00 p.m. to 10:30 p.m.

The reservation is for a whole table at a time. We only have tables of 10. (maximum 10 people per table)
The minimum consumption is calculated accordingly. There is generally no beer garden operation at the Spring Festival.

The minimum purchase for a reservation is as follows:

There is only one price category. Per reserved table in the central nave or in the side boxes, we charge: 60 stamps of 12.00 Euro each = 720.00 Euro. (per person 72.00 Euro)

In addition, you are welcome to book our "Schönigers Schmankerl Brett!" as an appetizer board via the reservation system for 94.50 Euro. The appetizer board is then already set at the table when you arrive.

Misuse of the stamps will be prosecuted.

You can purchase additional tokens in addition to the reservation in our marquee office (price 12.00 Euro per stamp).

All reserved seats are inclusive of service (no self-service). The consumption of food and drinks brought along is not permitted.

Cancellation / Disclaimer

Cancellations are only permitted in writing. Likewise, cancellations can only be made on a table-by-table basis. In the event of cancellation by 04/01/2025 (April) of the respective year, payments made by you for the stamps minus 10% cancellation fee minus the processing fee and shipping costs will be refunded after you have returned the stamps and admission wristbands to us (if already handed over). After 04/01/2025 (April), the cancellation fees amount to 20%.

In the event of a complete cancellation of the Munich Spring Festival, you will be refunded the fee already paid for the stamps. Reservation fee and shipping fee will be retained for processing reasons. Further claims against H. u. P. Schöniger GmbH are excluded in this case.

Handling charge

The processing fee is 1.50 euros per person and thus 15.00 euros for a table booking. Admission wristbands for the Festhalle Bayernland are also sent.

Dispatch of the value mark

Admission wristbands and stamps will be sent together. Shipping will take place from the end of January 2025. The amount of the actual shipping costs depends on the order value. The costs are calculated according to the insured value of the package and whether it is shipped nationally or internationally. The parcels are sent by courier and are only delivered in person against signature or handed over to the neighbour against signature.

Validity of stamps

The stamps taken are valid throughout the Munich Spring Festival from 25 April to 11 May 2025, as well as at all other folk festivals at which the Festhalle Bayernland is represented in 2025. (you can see the dates on the back of the stamps) Unused stamps can also be offset against food for outside the home.

The stamps are NOT valid at Oktoberfest Munich / Oide Wiesn 2025.

Payment of the reservation / consumption beyond / table bill

After you have made a reservation via our online portal, you will receive a request for payment. This is due for payment immediately. You can make the payment by bank transfer / direct debit / credit card to our reservation account. After that, you will receive a confirmed payment with invoice/receipt. Thus, your reservation is binding. Any consumption beyond this must be paid in cash or by EC card. In the Festhalle Bayernland there are also two ATMs available for cash withdrawals. The hospitality invoice can be issued for you by your local service staff on request. The purchased stamps will be offset by the service staff on the hospitality bill. Please always check your table bill directly when you make your payment. By making your payment, you confirm the correctness. Later complaints are not possible and are therefore excluded.

Reserved Seats / Reservation Time

Please take your seats on time and in full.

Reserved seats will be kept free for a maximum of **15 minutes** after the confirmed reservation time. In the event of a delay, there is no longer any entitlement to the seats despite the purchase of stamps. If you leave the table completely, even during the reservation period, the right to the reserved seats.

We reserve the right to move seats, in which case you will be notified by us. If the table is not occupied by 8 - 10 people, the waitress is entitled to fill the table with more people. There is no legal entitlement to reserved seats.

A reservation may not be passed on to third parties. In case of violation, we reserve the right to cancel the reservation. In this case, it is not possible to exchange the stamps.

The entitlement to the reserved seats does not begin until the confirmed time.

In the case of a binding table reservation, you agree that the desired reservation name will be legibly indicated on the seat card.

SAFETY INSTRUCTIONS / General information

Bringing backpacks and large pieces of luggage into the festival tent is prohibited. If necessary, you will be denied access to the festival tent!

Attach your wristbands to your wrist in accordance with the regulations so that security personnel can see that you have made a reservation.

The security personnel must be obeyed.

Lingering in the corridors with and without beer mugs is not permitted in and in front of the reserved areas for fire protection reasons, escape and rescue routes must be kept clear. There is no standing room to linger.

Smoking is prohibited in the entire marquee (also for e-cigarettes)! An outdoor smoking area is provided for this purpose.

For toddlers there is a changing area at the toilet facilities.

Lost and found items are brought by us to the VMS lost property office the next day.

The "exaggeration" of beer mugs is not permitted, and non-compliance will result in expulsion from the tent.

Dancing and standing on the beer tent tables is not permitted.

Pets are not allowed on the entire site.

Obviously intoxicated persons can be denied entry - despite a valid reservation..

Disguises / costumes in the marquee are undesirable - admission is reserved.

At bachelor parties, no drinks or food may be sold, due to youth protection and food law. In the event of non-compliance, the house ban can be issued by the security service. Bachelor parties must be registered.

In case of non-compliance with legal regulations, the guest will be expelled from the tent.

It is forbidden in and around the tent to record images or sound of guests secretly or without their consent to produce and publish. H. u. P. Schöniger GmbH / Festhalle Bayernland is responsible for this and cannot be prosecuted in the event of violations by third parties.

The advertising photographer employed by us is entitled to take photos and videos in the marquee and to use them exclusively for advertising purposes of the company H. u. P. Schöniger GmbH (Festhalle Bayernland). When staying in our marquee, you declare your consent to this.

It is forbidden to bring drinks, glass objects, weapons, drugs within the meaning of the Narcotics Act or other dangerous objects into the marquee. We are entitled to check objects (bags, backpacks, etc.) carried in the exercise of our domiciliary rights.

Intentional damage to the furnishings, such as benches, tables, etc., is due immediately and must be paid on site. Otherwise, criminal charges will be filed for damage to property.

Please continue to observe the following important information / regulations: We would like to point out that current pandemic regulations must be observed. Among other things, the current and specified infection control measures (according to applicable law) always apply.

Intentional damage to the furnishings, such as benches, tables, etc., is due immediately and must be paid on site. Otherwise, criminal charges will be filed for damage to property.

Protection of minors: Children and young people **under the age of 16** are not permitted to stay in beer tents and beer gardens without being accompanied by a parent or guardian. After 8:00 p.m., no children **under the age of 6** are allowed in the beer tent, even if they are accompanied by their parents, a person with custody or legal guardianship. The Youth Protection Act also applies to reservations. Alcoholic beverages may not be sold to children and adolescents **under the age of 16**, nor may their consumption be permitted, even if accompanied by a parent or guardian. The sale of spirits and liqueurs to young people **under the age of 18** is not permitted.

If you become infected with infectious diseases during your stay in the marquee, H. u. P. Schöniger GmbH has no liability.
